1. Who is responsible for processing my data?

2. What data do we process from you and for what purpose?

We process your personal data in connection with the preparation, holding and post-processing of the Infineon Technologies AG Capital Markets Day 2021.

If you register for the Capital Markets Day, we will process your First Name, Last Name, Company, E-Mail and Interest Group. In order to submit your questions we process your provided personal data. We do not publish or mention your name publicly when we answer your question.

The legal basis for processing in these cases is Art. 6 para. 1 sentence 1 lit. c) GDPR.
In accordance with Art. 6 para. 1 sentence 1 lit. a) GDPR.

3. Cookies

The online service of the Infineon Technologies AG Capital Markets Day 2021, to which registered participants have access, only uses technically necessary cookies.

Such cookies allow you to use the online service comprehensively. Without these cookies, essential functions could not be provided. Consequently, these cookies cannot be deactivated. However, technically necessary cookies are usually deleted once the browser has been closed.

4. How long do we save your data?

We only store your personal data for as long as the preparation, holding and post-processing of the Infineon Capital Markets Day requires.

5. Who do we share data with?

We use external service providers for the handling of the Infineon Capital Markets Day 2021, who process your data exclusively within the EU.

We may also share your personal data with Infineon Technologies AG as the organizer and host of the Capital Markets Day 2021. We enter into contracts with our service providers and business partners in which the requirements of relevant data protection laws are addressed.

6. What rights do I have as an affected person?

You may claim certain rights under the GDPR and other relevant data protection regulations.

Under the GDPR, you are entitled to claim the following specific rights vis-à-vis Promeas GmbH as the data subject:

- the right of access by the data subject (Art. 15 GDPR)
- the right of rectification (Art. 16 GDPR)
- the right to erasure (Art. 17 GDPR)
- the right to restriction of processing (Art. 18 GDPR)
- the right to data portability (Art. 20 GDPR)
- the right to object (Art. 21 GDPR).
